The services will be performed both remotely at the external examiner's premises and on target services sites (see call for applications for more information).

#### II.2.4) Description of the procurement:

The European Central Bank (ECB) is seeking a supplier for the performance of external examinations of the target services, with a focus on the TARGET services shared components and the T2S specific components. The term 'TARGET services' encompasses TARGET2; TARGET2-Securities(T2S), TARGET Instant Payment Settlement (TIPS), as well as any other TARGET service/system that might go live during the lifespan of the Contract.

The scope of the examinations shall be limited to the provision of TARGET services or directly related activities. The services are expected to comprise the financial years 2023, 2024, 2025 and 2026. The successful tenderer is expected to perform the annual regular examinations, starting with the hand-over from the previous examiner during 2023 and subsequent the yearly examination of financial year ('FY') 2023 that will take place in 2024. The FY 2023 examination will focus on the TARGET services shared components and on the T2S specific components. Optionally, the ECB may require the external examiner to also perform regular examinations of the T2 and/or TIPS Specific components within the duration of the contract.

The external examiner shall perform the services in accordance with internationally recognised audit standards such as the International Standard on Assurance Engagements (ISAE) No. 3402, 'Assurance Reports on Controls at a Service Organization', which was issued in June 2011 by the International Auditing and Assurance Standards Board (IAASB), which is part of the International Federation of Accountants (IFAC). ISAE 3402 prescribes service organization control (SOC) reports, which help give assurance to the organisation's customers and service users. There are two kinds of SOC reports:

• SOC1 Type I report: documents a 'snapshot' of the organisation's controls;

• SOC2 Type II report: documenting over a period of time showing how effectively controls have been managed over time.

The Services will be performed both remotely at the external examiner's premises and on TARGET services sites. On site examination visits are expected to take place at the ECB's premises in Frankfurt, as well as at the premises of the four Central Banks operating TARGET services, namely Banca d'Italia, Banco de España, Banque de France and Deutsche Bundesbank (4CB).

The outcome of the external examination, especially the management letter, the detailed report, and any recommendation put forward by the external examiner, shall be produced in English. However, the on-site

	examination visits should be carried out by staff of the external examiner speaking fluently English (for ECB visits), or the local language of the four Central Banks operating T2S.
