## Reason for change and expected benefits/business motivation:

The T2S "BankToCustomerDebitCreditNotificationV03 (camt.054.001.03)" message does not yet provide a business reference, where the link to the original event can be reproduced. The population of ISIN, Corporate Action Event Identification and T2S Securities Account would facilitate work for the business departments Custody/Asset Servicing and Reconciliation.

## Description of requested change:

Currently, in camt.054\_T2S the following tags were removed, but are available in MX\_camt.054:

#### 1) ISIN

- 2) Corporate Action EventIdentification and EventType
