Reason for change and expected benefits/business motivation:

In order to allow the implementation of CSDR change requests it is necessary to align the messages used in T2S with the latest ISO version currently available, i.e. the implementation of ISO Maintenance Releases 2013 - 2017 is required. The Change Request T2S-0612-SYS (Alignment of T2S Messages with ISO Maintenance Releases 2013 - 2017)¹ has been created in order to align T2S messages with ISO Maintenance Releases 2013 - 2017)¹ has

However, the scope of CR-612 does not include the update of other non ISO communications in T2S as the Flat files, DMT files and Securities Valuation flat files. Considering that the development of these non ISO communications in T2S is aligned to the respective T2S messages based on ISO Release 2011/2012, implementing only CR-612 may lead to inconsistencies between non ISO communications (based in ISO Release 2011/2012) and their respective T2S messages (to be based on ISO Release 2017).

The 4CB recommends that in order to avoid deviations from the like-for-like approach applicable for Flat files, DMT files and Securities Valuation flat files and to ensure compliance of these communications with ISO Maintenance Release 2017, these non ISO communications shall be aligned accordingly.

Description of requested change:

The alignment of the T2S messages with the ISO Maintenance Releases 2013 - 2017 may lead to changes on the Flat files, DMT files and Securities Valuation flat files.

In order to ensure the like-for-like approach, the updates to be performed in the respective T2S messages shall be implemented for Flat files, DMT files and Securities Valuation flat files.
